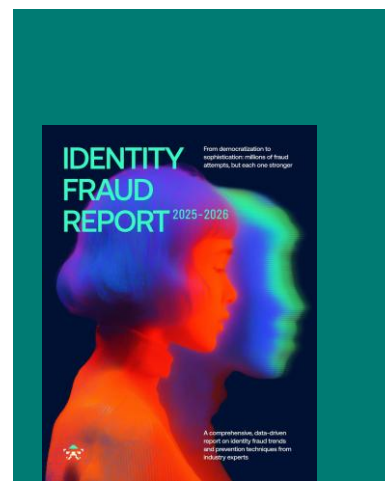

FIFA. MEXICAN AUTHORITIES AND FIFA NEED TO TALK!

Guadalajara — With six months remaining until the FIFA World Cup 2026, Guadalajara, one of the tournament’s host cities, has been placed on high alert following recent shootouts that resulted in the death of Nemesio Rubén Oseguera Cervantes, also known as “**El Mencho**,” leader of the Jalisco New Generation Cartel (CJNG).

Amid growing security concerns, **FIFA has canceled 800 of the 2,000 hotel reservations originally made** in preparation for the World Cup.

According to the director general of the Mexico City Hotel Association, FIFA did not provide an explanation for the cancellations. In response, Foreign Affairs Minister Juan Ramón de la Fuente and **Omar García Harfuch** met with FIFA representatives to address safety issues surrounding the event. Officials later stated that FIFA is coordinating with the federal government, state authorities, and local municipalities to ensure the safety of residents and international visitors during the tournament.-
